






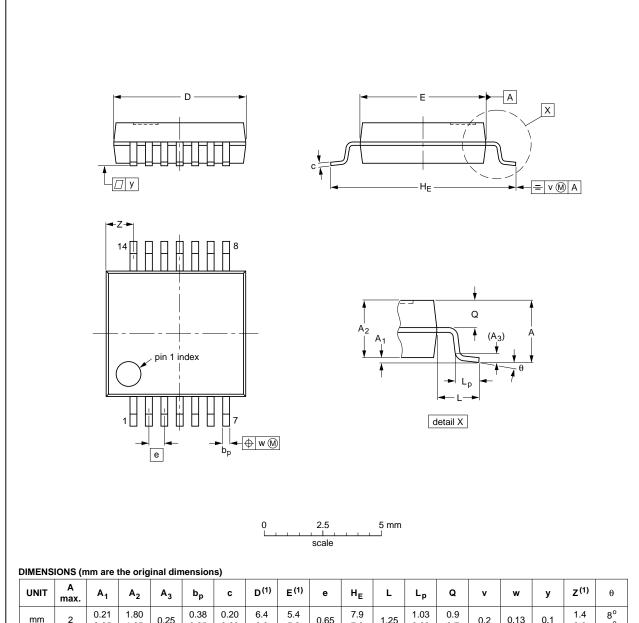

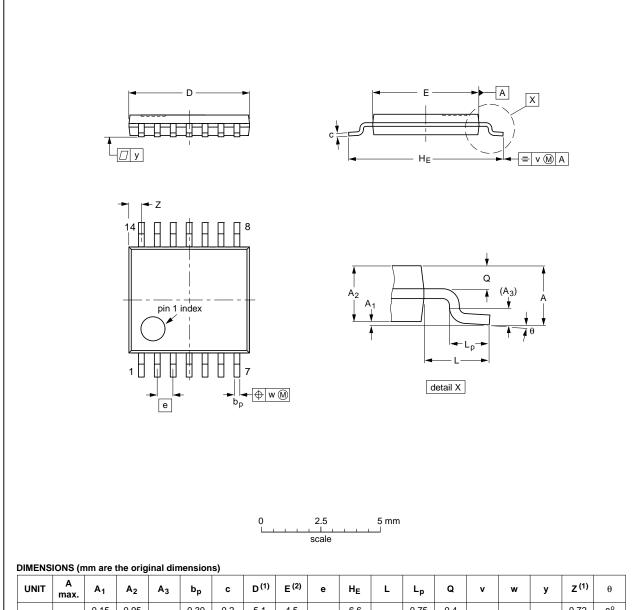

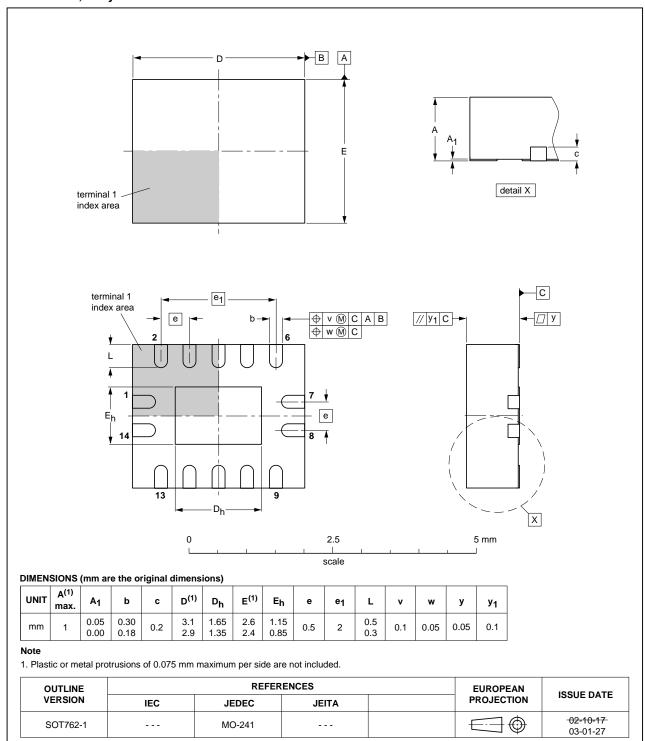


Fig 12. Package outline SOT762-1 (DHVQFN14)
