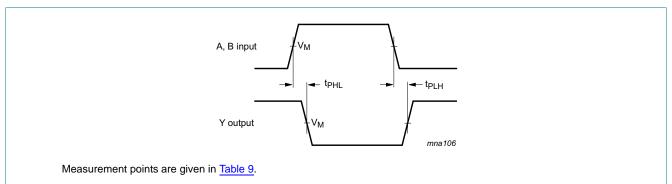
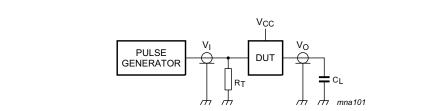


Fig 5. The inputs (A and B) to output (Y) propagation delays

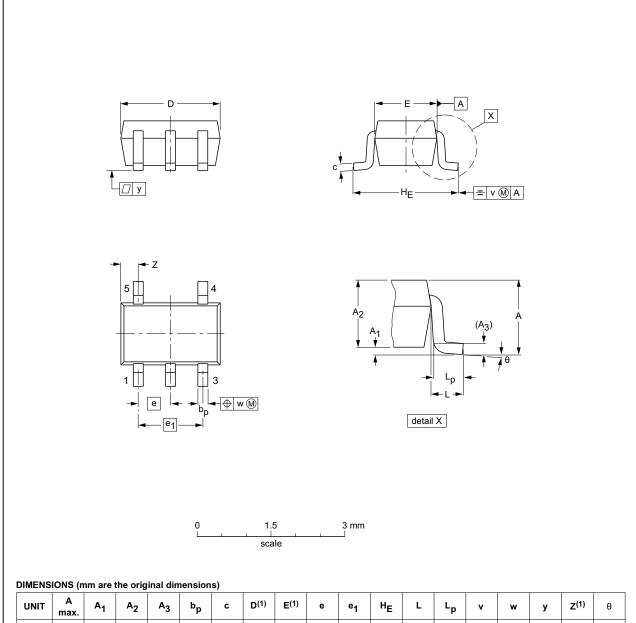

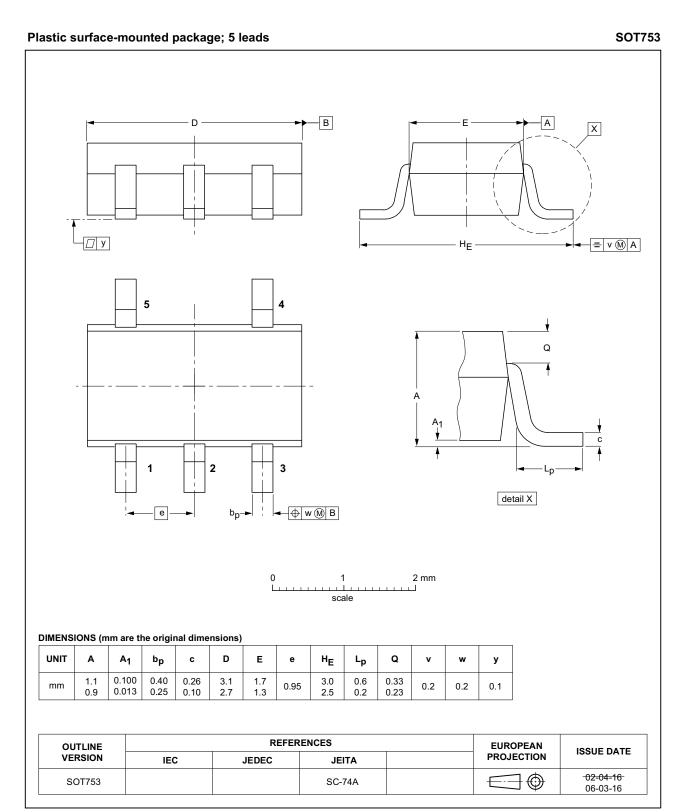


Fig 8. Package outline SOT753 (SC-74A)
