# General Description

FSBS15CH60F is a Motion SPM<sup>®</sup> 3 module providing a fully-featured, high-performance inverter output stage for AC Induction, BLDC, and PMSM motors. These modules integrate optimized gate drive of the built-in IGBTs to minimize EMI and losses, while also providing multiple on-module protection features including under-voltage lockouts, over-current shutdown, and fault reporting. The built-in, high-speed HVIC requires only a single supply voltage and translates the incoming logic-level gate inputs to the high-voltage, high-current drive signals required to properly drive the module's internal IGBTs. Separate negative IGBT terminals are available for each phase to support the widest variety of control algorithms.

#### 3rd Notes:

1. RC coupling at each input (parts shown dotted) might change depending on the PWM control scheme in the application and the wiring impedance of the application's printed circuit board. The Motion SPM<sup>®</sup> 3 Product input signal section integrates a 3.3 kΩ(typ.) pull-down resistor. Therefore, when using an external filtering resistor, pay attention to the signal voltage drop at input terminal.

2. The logic input works with standard CMOS or LSTTL outputs.



### These values depend on PWM control algorithm.

3. It would be recommended that the bootstrap diode, D<sub>BS</sub>, has soft and fast recovery characteristics.

4. The bootstrap resistor (R<sub>BS</sub>) should be three times greater than R<sub>E(H)</sub>. The recommended value of R<sub>E(H)</sub> is 5.6 Ω, but it can be increased up to 20 Ω (maximum) for a slower dv/ dt of high-side.

5. The ceramic capacitor placed between  $V_{CC}$  - COM should be over 1  $\mu$ F and mounted as close to the pins of the Motion SPM 3 product as possible.

### 4th Notes:

- 1. To avoid malfunction, the wiring of each input should be as short as possible (less than 2 3 cm).
- 2. By virtue of integrating an application-specific type of HVIC inside the Motion SPM<sup>®</sup> 3 product, direct coupling to MCU terminals without any optocoupler or transformer isolation is possible.
- 3. V<sub>FO</sub> output is open-collector type. This signal line should be pulled up to the positive side of the 5 V power supply with approximately 4.7 kΩ resistance (please refer to Figure 9).
- 4.  $C_{\text{SP15}}$  of around seven times larger than bootstrap capacitor  $C_{\text{BS}}$  is recommended.
- 5. V<sub>FO</sub> output pulse width should be determined by connecting an external capacitor (C<sub>FOD</sub>) between C<sub>FOD</sub> (pin 7) and COM (pin 2). (Example : if C<sub>FOD</sub> = 33 nF, then t<sub>FO</sub> = 1.8 ms (typ.)) Please refer to the 2nd note 5 for calculation method.
- 6. Input signal is active-HIGH type. There is a 3.3 kΩ resistor inside the IC to pull down each input signal line to GND. When employing RC coupling circuits, set up such RC couple that input signal agree with turn-off / turn-on threshold voltage.
- 7. To prevent errors of the protection function, the wiring around  $\mathsf{R}_\mathsf{F}$  and  $\mathsf{C}_\mathsf{SC}$  should be as short as possible.
- 8. In the short-circuit protection circuit, please select the  $R_F C_{SC}$  time constant in the range 1.5 ~ 2  $\mu s.$
- 9. Each capacitor should be mounted as close to the pins of the Motion SPM 3 product as possible.
- 10. To prevent surge destruction, the wiring between the smoothing capacitor and the P & GND pins should be as short as possible. The use of a high-frequency non-inductive capacitor of around 0.1 ~ 0.22 μF between the P & GND pins is recommended.
- 11. Relays are used in almost every systems of electrical equipment in home appliances. In these cases, there should be sufficient distance between the MCU and the relays.
- 12.  $C_{SPC15}$  should be over 1  $\mu F$  and mounted as close to the pins of the Motion SPM 3 product as possible.
