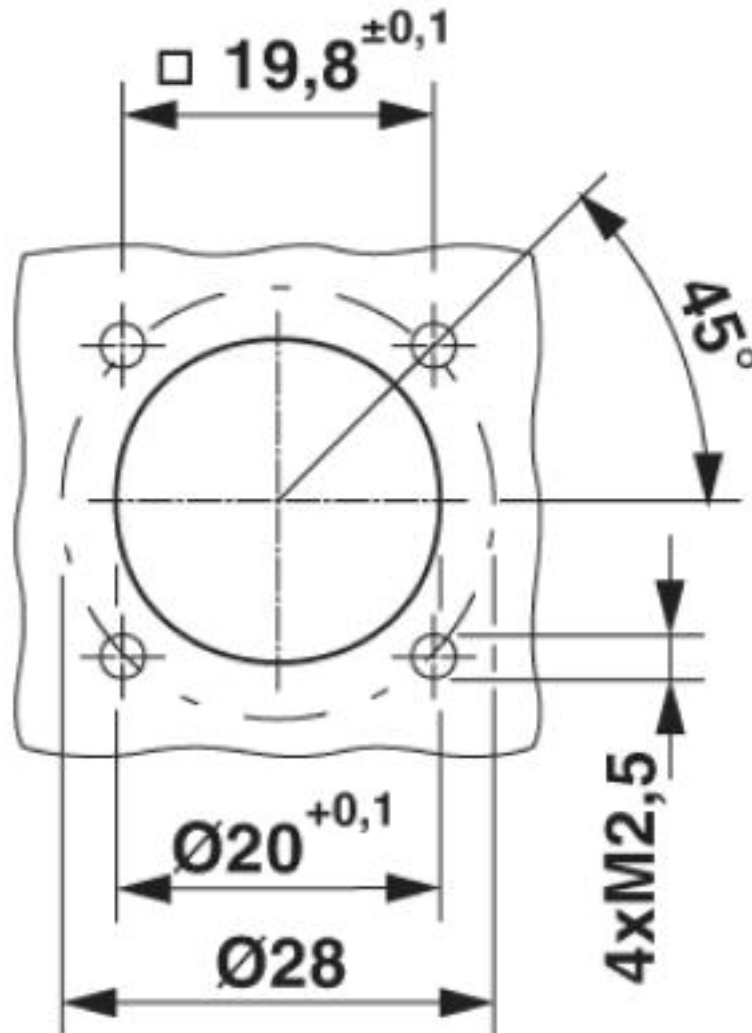

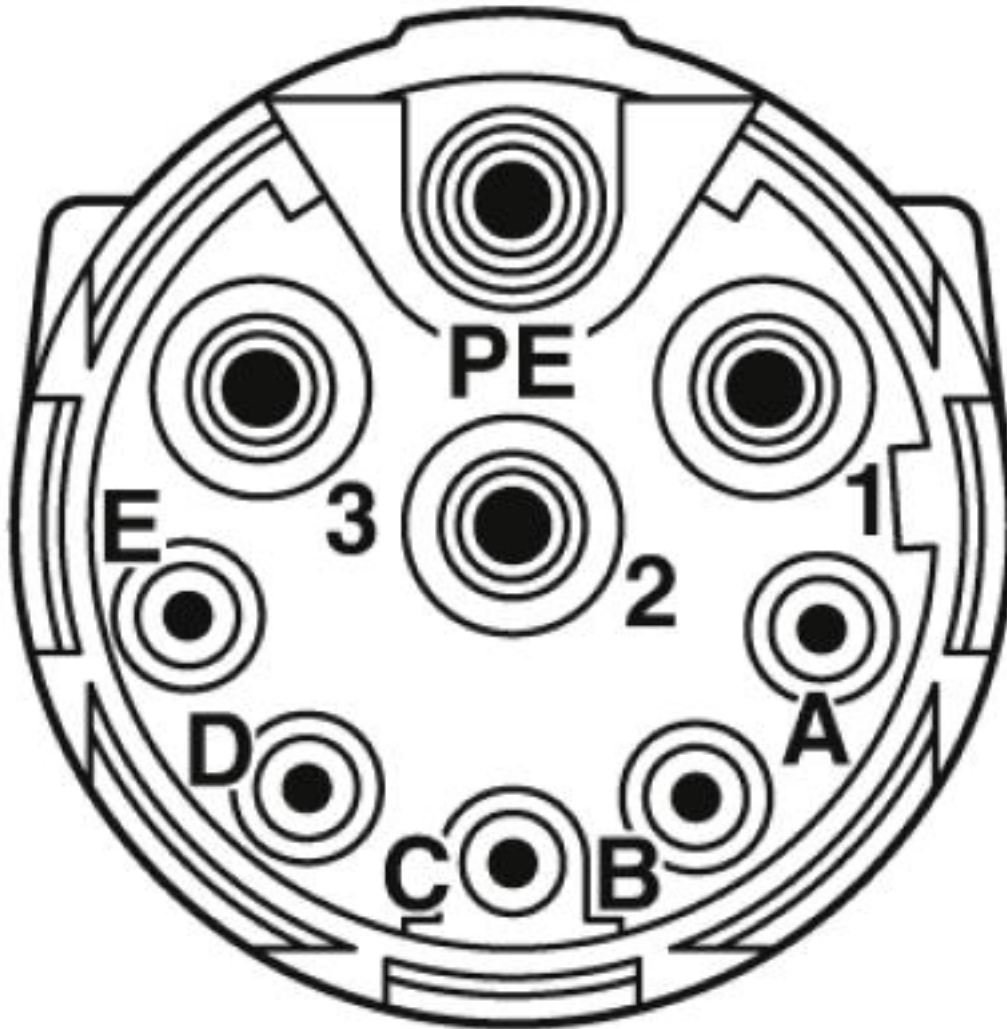

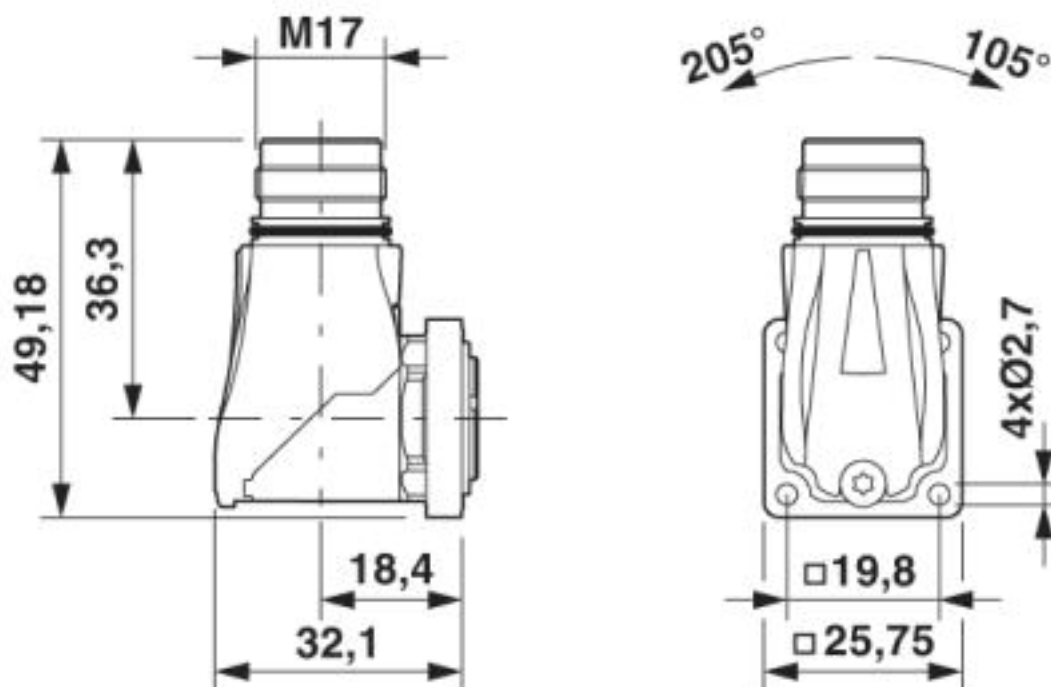
Schematic diagram
