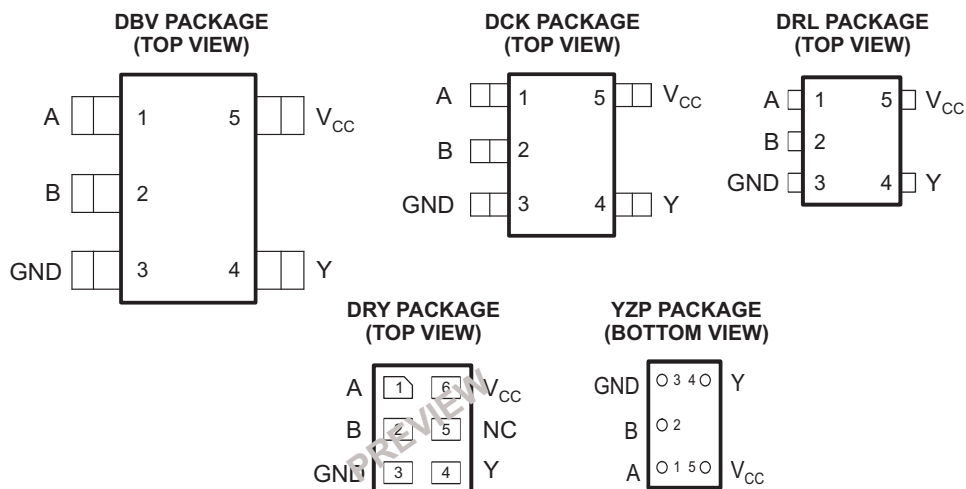

DESCRIPTION/ORDERING INFORMATION

This single 2-input positive-AND gate is operational at 0.8-V to 2.7-V V_{CC} , but is designed specifically for 1.65-V to 1.95-V V_{CC} operation.

The SN74AUC1G08 performs the Boolean function $Y = A \cdot B$ or $Y = \overline{A} + \overline{B}$ in positive logic.

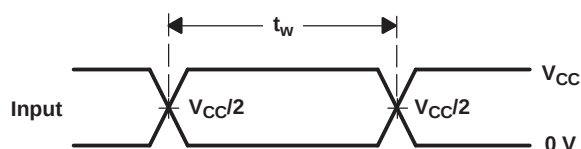

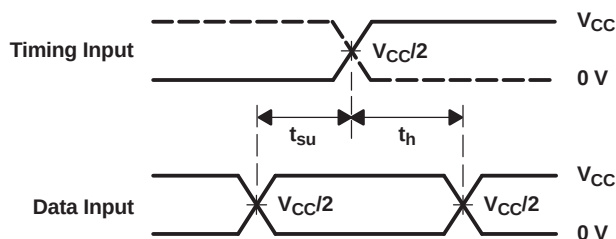

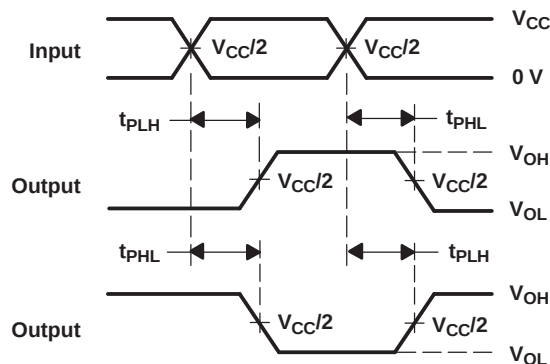

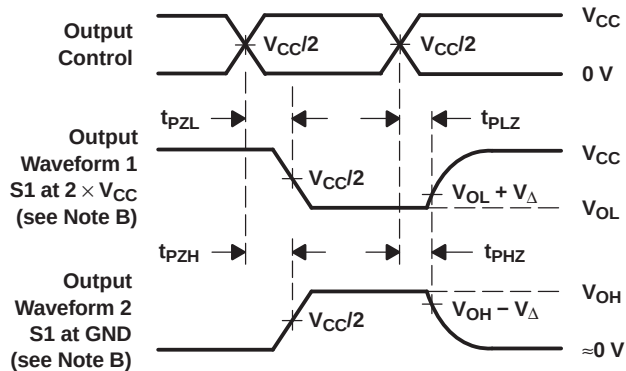
VOLTAGE WAVEFORMS

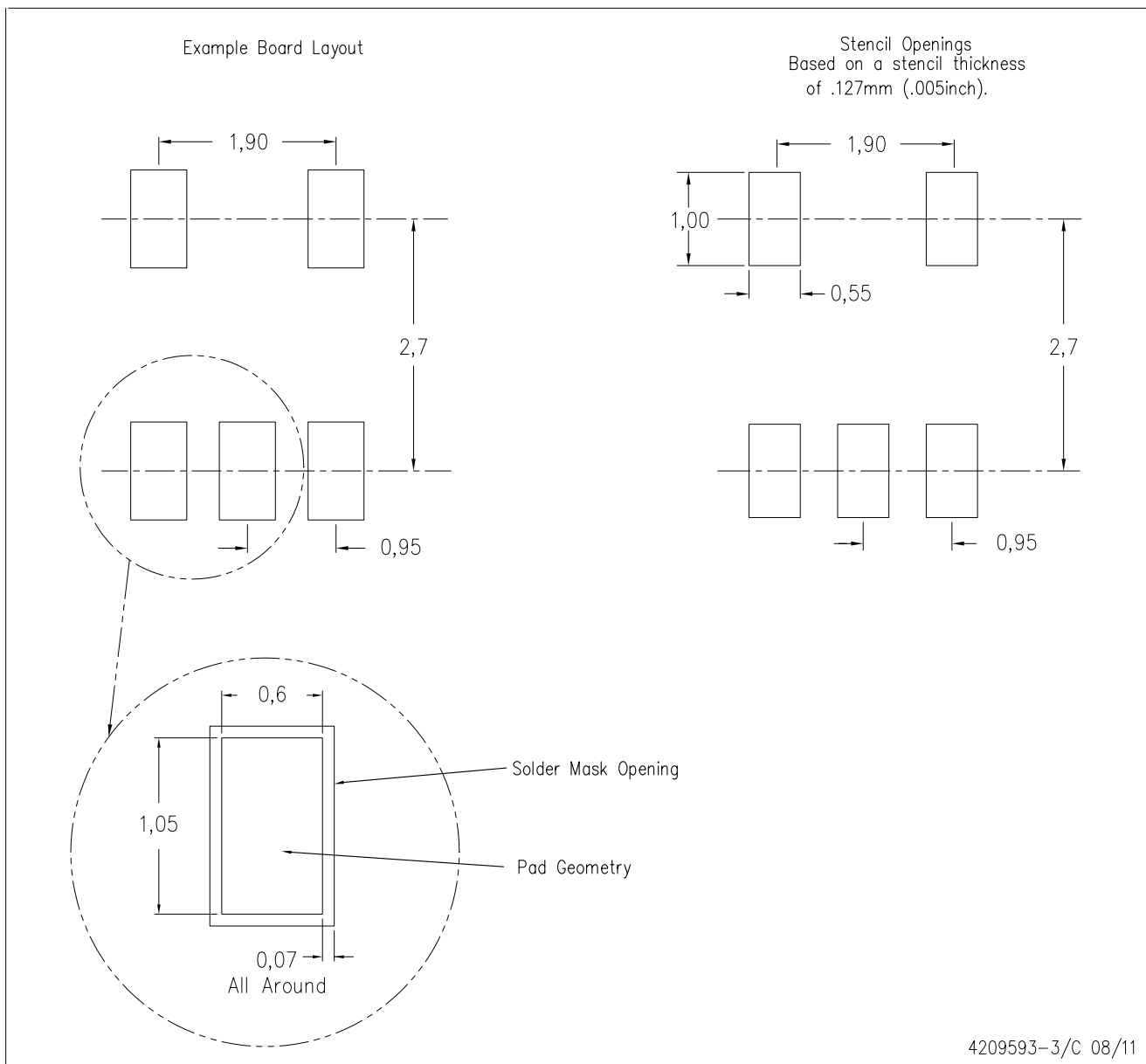

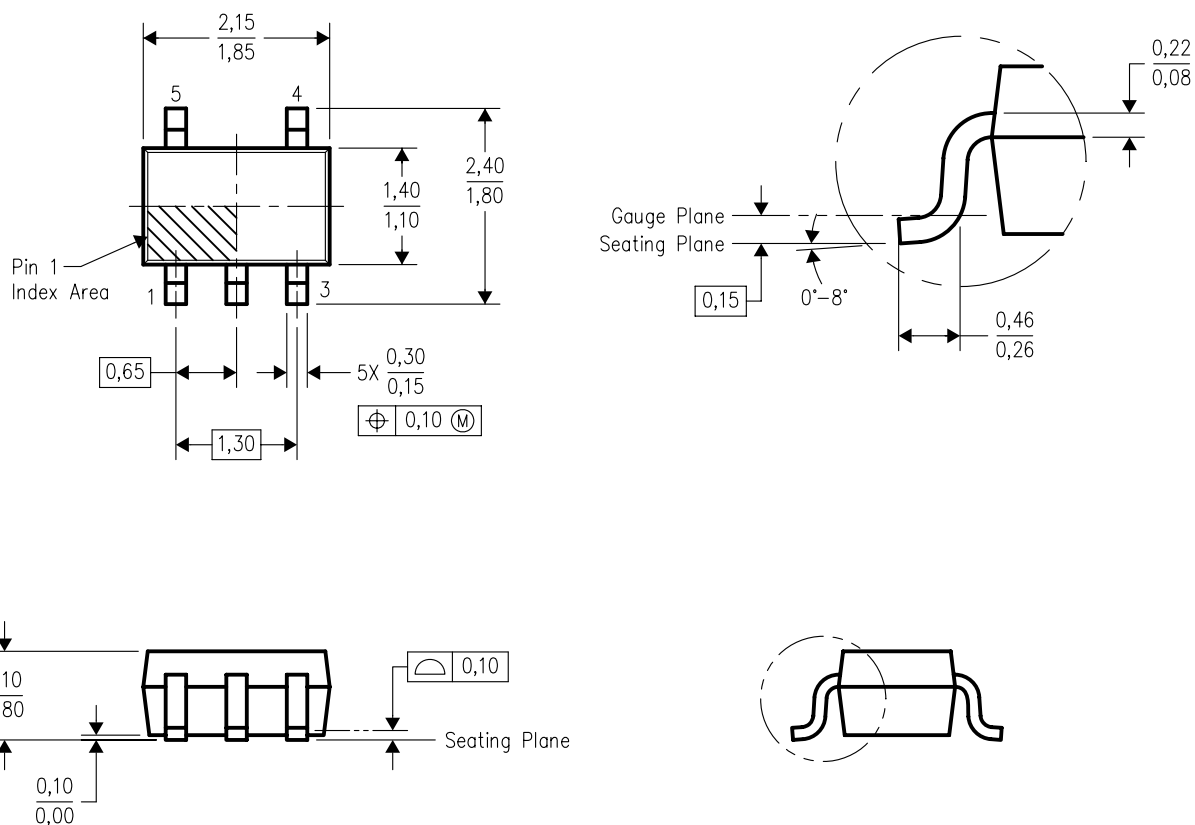

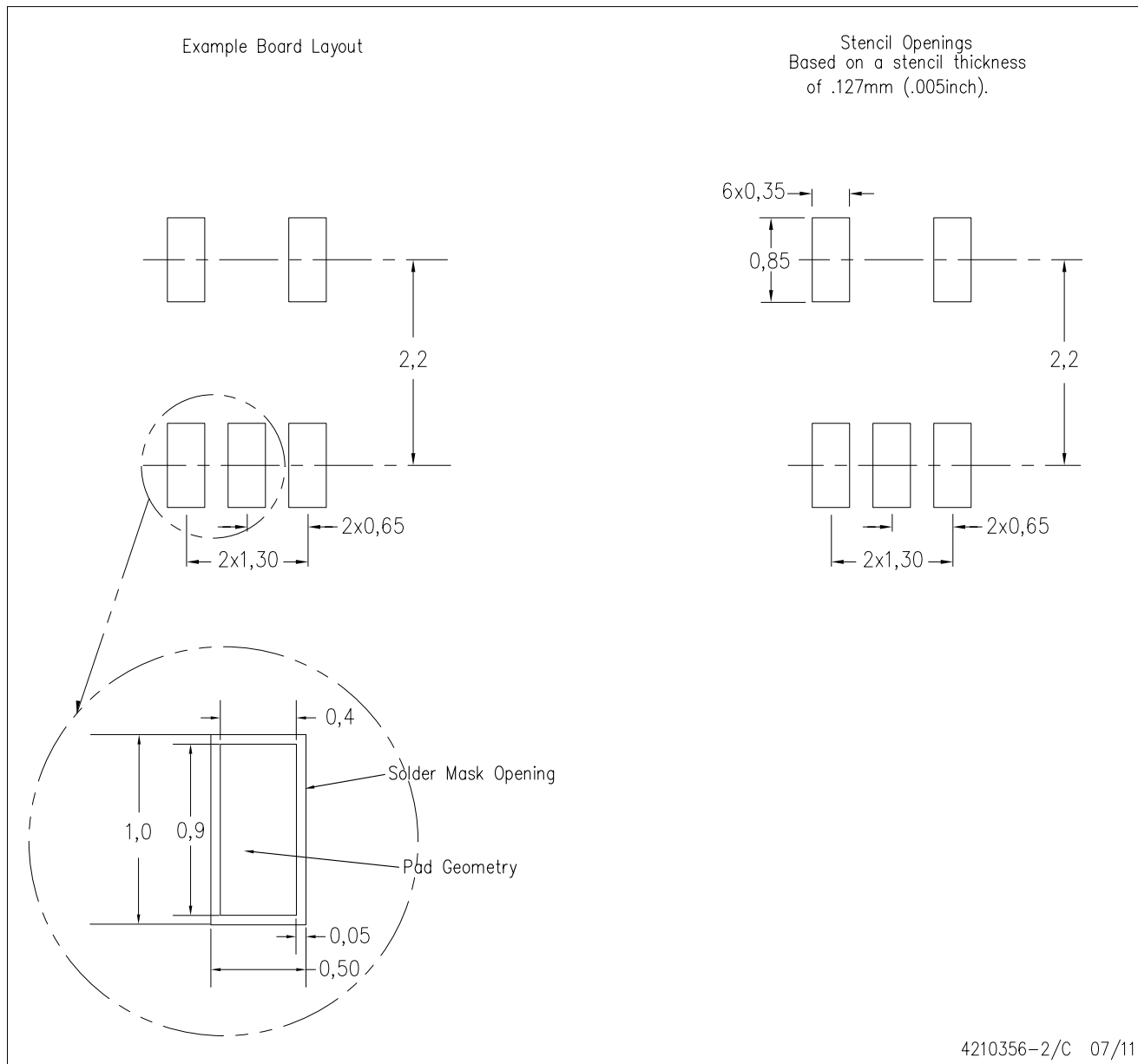

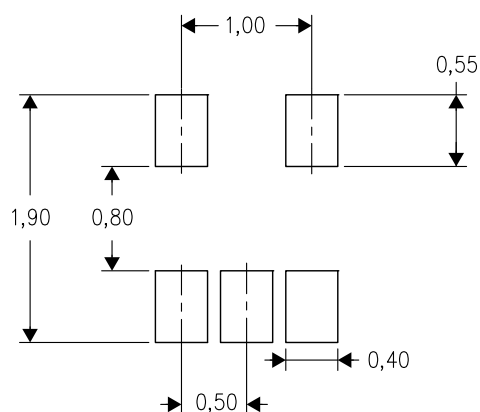

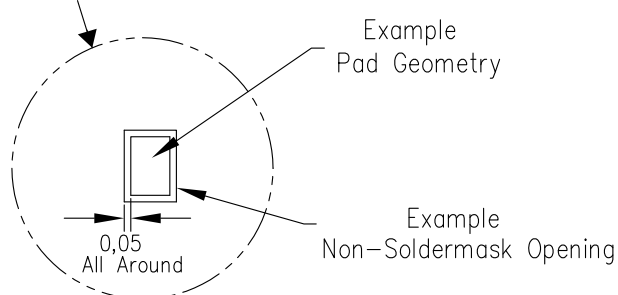
Example Board Layout

Pad Geometry

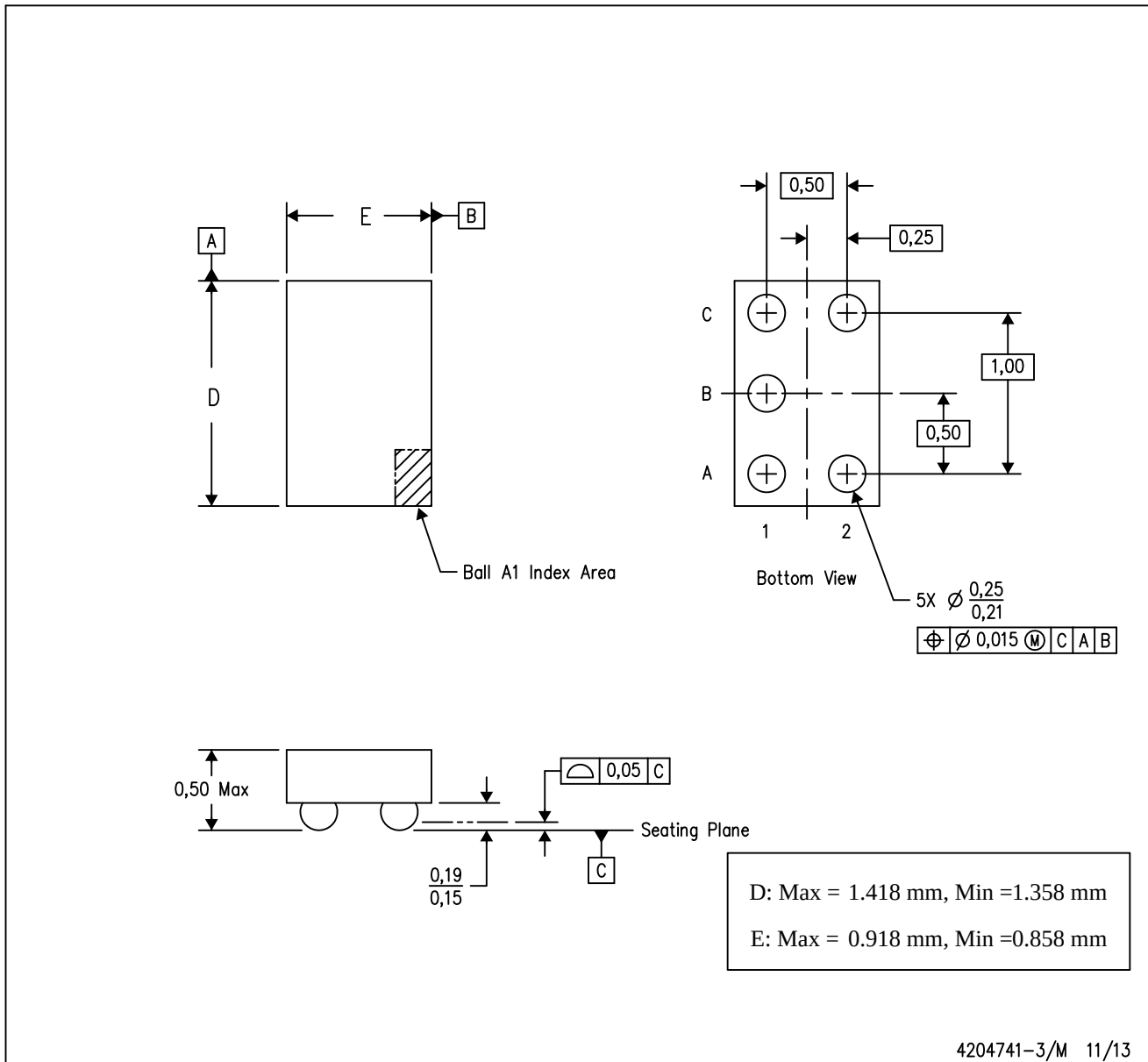
