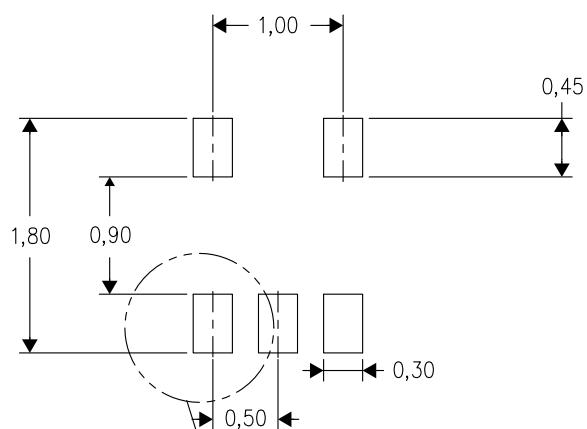

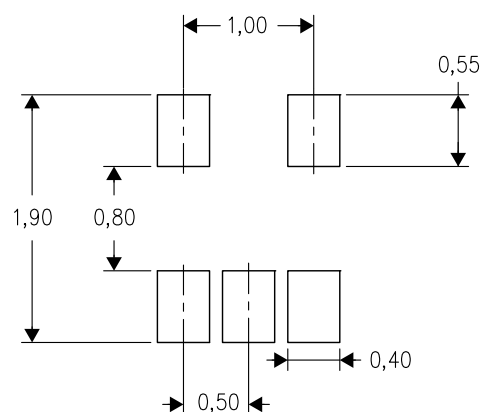

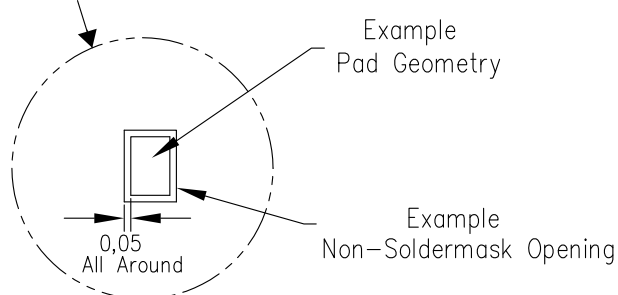
Example Board Layout

Non-Soldermask Defined Pad

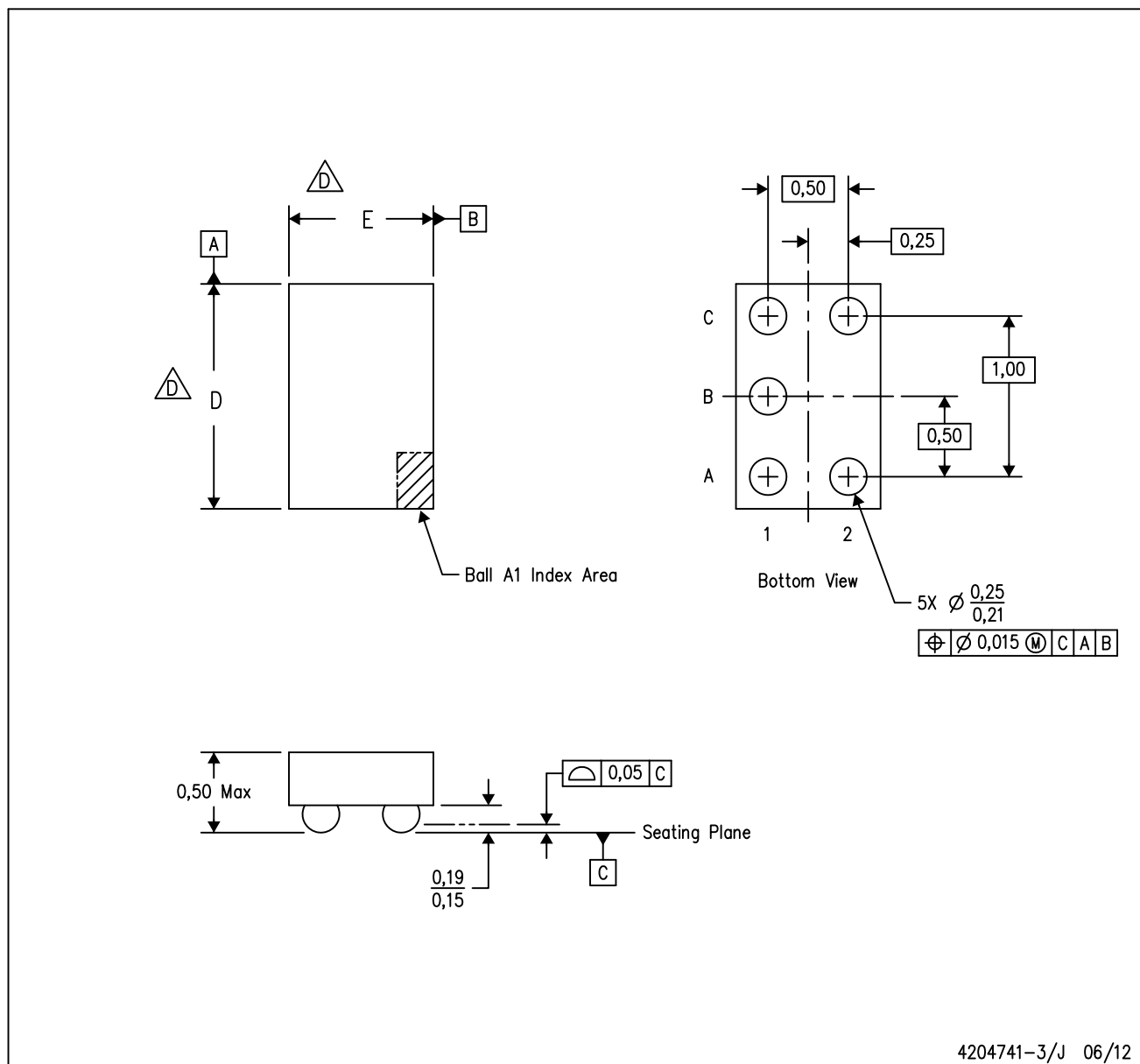
