It achieves the high speed operation similar to equivalent LSTTL while maintaining the CMOS low power dissipation.


The internal circuit is composed of 2-stages including buffer output, which provide high noise immunity and stable output.





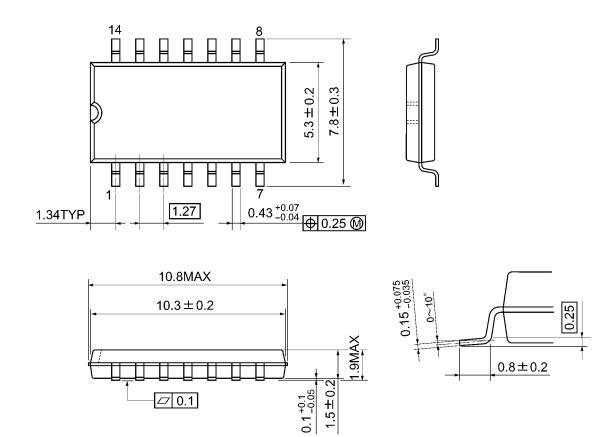
