The TC74HC11A is a high speed CMOS 3-INPUT AND GATE fabricated with silicon gate $\rm C^2MOS$ technology.


It achieves the high speed operation similar to equivalent LSTTL while maintaining the CMOS low power dissipation.

The internal circuit is composed of 4 stages including a buffer output, which provide high noise immunity and stable output.

All inputs are equipped with protection circuits against static discharge or transient excess voltage.







Package Dimensions


DIP14-P-300-2.54 Unit: mm
