The TC74HC4078A is a high speed CMOS 8-INPUT NOR GATE fabricated with silicon gate C^2 MOS technology.


It achieves the high speed operation similar to equivalent LSTTL while maintaining the CMOS low power dissipation.







Package Dimensions


DIP14-P-300-2.54 Unit: mm
