Planar passivated high commutation three quadrant triac in a SOT78 (TO-220AB) plastic package intended for use in circuits where high static and dynamic dV/dt and high dl/dt can occur. This "series B" triac will commutate the full RMS current at the maximum rated junction temperature without the aid of a snubber.






Fig. 1. RMS on-state current as a function of mounting base temperature; maximum values



 $f = 50 \text{ Hz}; T_{mb} = 100 \,^{\circ}\text{C}$


Fig. 2. RMS on-state current as a function of surge duration; maximum values




Fig. 5. Non-repetitive peak on-state current as a function of the number of sinusoidal current cycles; maximum values





Fig. 7. Normalized gate trigger current as a function of junction temperature




Fig. 8. Normalized latching current as a function of junction temperature





Fig. 9. Normalized holding current as a function of junction temperature




