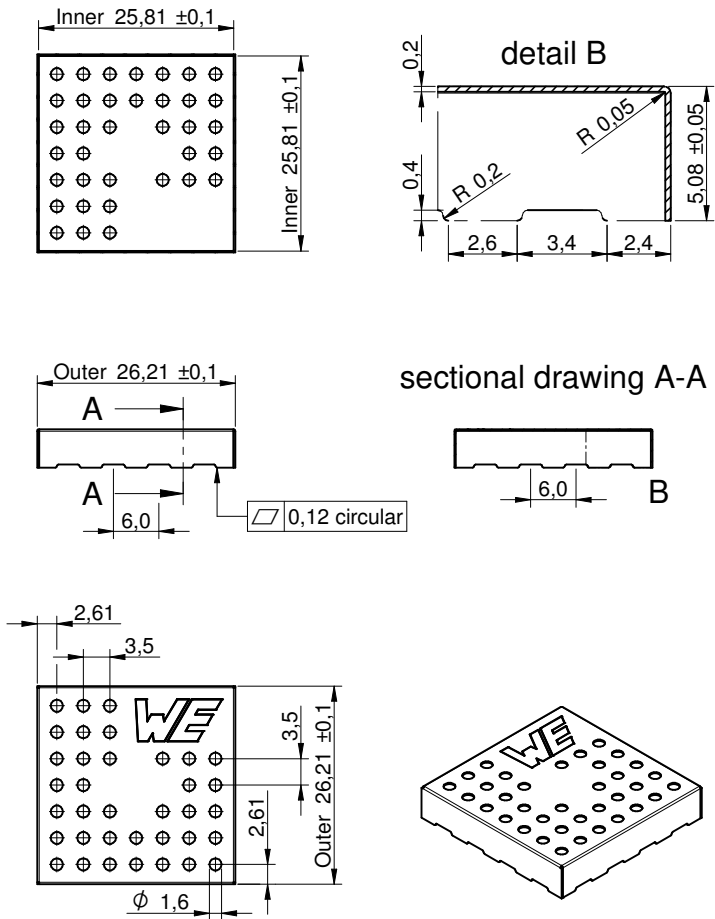
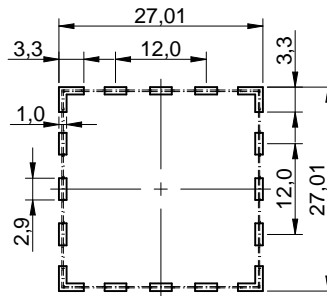



### 6. Product Life Cycle



