Typical Impedance Characteristics:




Typical Differential Mode Insertion Loss Characteristics:







Typical Common Mode Insertion Loss Characteristics:





Product specific:

Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- All other soldering methods are at the customers' own risk.
- Strong forces which may affect the coplanarity of the components' electrical connection with the PCB (i.e. pins), can damage the part, resulting in avoid of the warranty.

Cleaning and Washing:



Storage Conditions:


