
Common Mode



#### Soldering

## Potting

If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. Shrinking
could lead to an incomplete seal, allowing contaminants into the core. Expansion could damage the component. We recommend a
manual inspection after potting to avoid these effects.
