Differential Mode



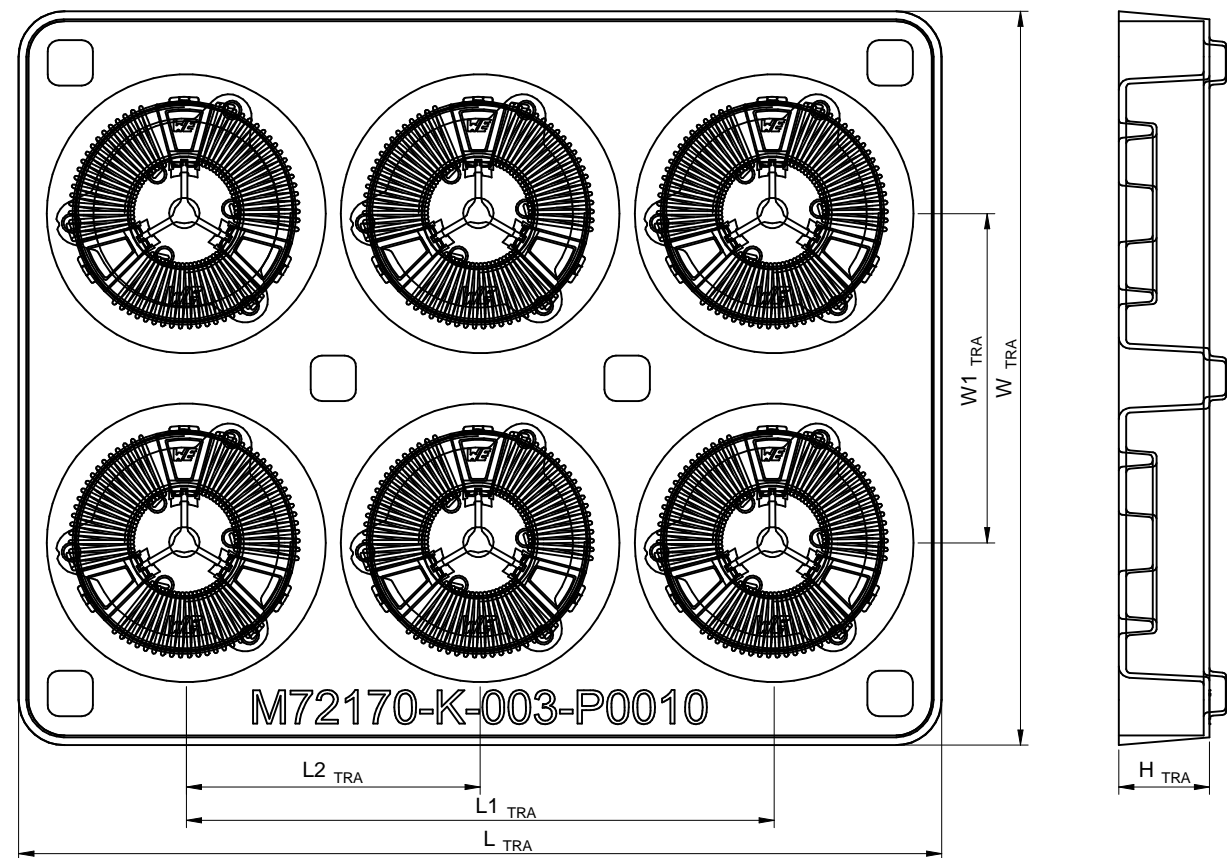

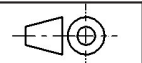

### Storage Conditions:


